



What to Bring – Real ID Required Documents

The U.S. Department of Homeland Security REAL ID Act became effective nationwide in 2008, mandating new standards for the issuance of driver licenses and identification cards. Florida began issuing REAL ID-compliant credentials January 1, 2010. New driver licenses and ID cards have a star in the upper right corner of the card, indicating that they are REAL ID-compliant. As part of the REAL ID Act, there are documentation requirements for residents renewing or obtaining a new driver license or ID card. **For the first in-office issuance after January 1, 2010, customers must bring original documents that validate their identity, Social Security Number (SSN) and residential address. Be REAL ID Ready – Deadline is MAY 3, 2023.**

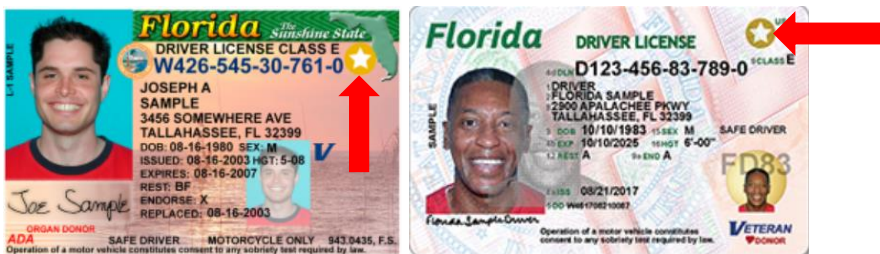

Customers MUST visit an office with the required documents IF:

- You are applying for your first driver license or ID card
- Your current credential expires, and your current driver license or ID card does not have a star in the upper corner; or
- You have legally changed your name since your last issuance (e.g., by marriage, divorce, or court order)
 - The name(s) on your marriage certificate(s) or court order must show how your birth name was changed to your current name
 - If your name has changed multiple times, and the document you provide shows your current name and your birth name, you need only bring the final name change document
 - If the final marriage certificate does not have both names, you will need to bring all documents that show how your name changed from birth name to current name

NOTE: In accordance with the REAL ID Act, once a customer provides the required identity documents, they will only need to provide them again if their information changes (e.g., name, residential address). **After May 3, 2023, the Transportation Security Administration (TSA) will only accept driver licenses and ID cards with a star in the upper right corner as proof of identification at airports.** Individuals currently seeking access to military bases and most Federal facilities must present REAL ID-compliant identification. A United States passport may also be used in place of a REAL ID-compliant card for official identification.

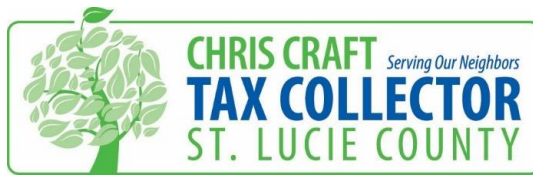

U.S. Citizen

U.S. citizens renewing, replacing, or applying for a new driver license or ID card in person must submit the following documents before a REAL-ID compliant driver license or ID card can be issued. Please note that the name assigned to the Social Security Number (SSN) **must match** the name that will appear on the Florida driver license or ID card. If you have recently changed your name, you must update your records with the Social Security Administration before applying for a driver license or ID card. Please allow 24 to 48 hours after changing your name with Social Security Administration before applying to change it with the Florida Department of Highway Safety and Motor Vehicles.

Primary Identification

1. An original of **ONE** of the following documents with complete name:
 - U.S. birth certificate, including U.S. territories and District of Columbia (birth certificates from Puerto Rico must have an issue date after July 1, 2010);
 - Valid U.S. passport or passport card;
 - Consular Report of Birth Abroad;
 - Certificate of Naturalization, form N-550 or form N-570; or
 - Certificate of Citizenship, form N-560 or form N-561.

NOTES:

- Only a birth certificate issued by a [county health department](#) or the [CDC Bureau of Vital Statistics](#) will be accepted. **Hospital birth certificates are not considered a certified document and will not be accepted.**
- Please come prepared to present one of the above listed identification documents as proof of citizenship or legal presence.
- When applicable, marriage certificates, court orders or divorce decrees must be provided to link the name on the primary identification to the name on the driver license or ID card.
- If a valid U.S. passport has your current name, you are not required to present additional name change documents.

Proof of Social Security:

2. An original of **ONE** of the following documents with complete name and complete SSN:
 - [Social Security card](#) (with your current name);
 - Self-Certification Form (number must verify in our system)
 - W-2 form (not handwritten);
 - Paycheck/stub;
 - SSA-1099; or
 - Any 1099 (not handwritten).

Proof of Residential Address - **Class E, Learner's License & Identification Cards ONLY**

You may not use your current driver license or ID card as proof of residential address. You must submit **TWO different** documents with your residential address (printouts or faxes of these documents are acceptable). Residential address documents include, but are not limited to:

- Deed, mortgage, monthly mortgage statement, mortgage payment booklet or residential rental/lease agreement;
- Florida voter registration card;
- Florida vehicle registration or title;
- Utility bill;

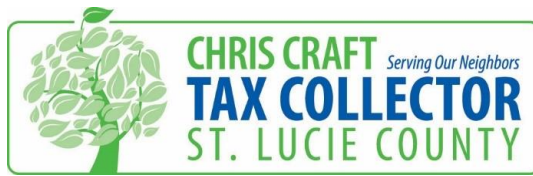

- A utility hook-up or work order dated within 60 days prior to the application;
- Automobile payment booklet;
- Selective service card;
- Medical or health card with address listed;
- Current homeowner insurance policy or bill;
- Current automobile insurance policy or bill;
- Educational institution transcript forms for the current school year;
- Unexpired professional license issued by a government agency in the U.S.;
- W-2 form or 1099 form;
- Form DS2019, Certificate of Eligibility for Exchange Visitor (J-1) status;
- A letter from a homeless shelter, transitional service provider or a half-way house verifying they receive mail for the customer. The letter must be accompanied by a [Certification of Address](#) form;
- Mail from financial institutions including checking, savings or investment account statements;
- Mail from federal, state, county or city government agencies; or
- FDLE registration form completed by local sheriff's department.

VETERANS – Don't forget to bring your DD-214 showing discharge or release under conditions other than a dishonorable or uncharacterized to have the veteran designation added to your license.



NOTE: If you do not have any of the above documents in your name, you may provide two proofs of residential address from a parent, step-parent, legal guardian— or other person with whom you reside and a [Certification of Address](#) form.

Name Changes:

- If you have legally changed your name by marriage, divorce or court order, you must submit the original or a certified marriage certificate, divorce decree or court order.
- **Photocopies are not accepted.**
- Marriage certificates must be recognized by the state of Florida. Generally, marriage certificates issued in Florida or another state in accordance with the respective laws of those states are recognized by the State of Florida.
- **Church-issued marriage certificates are not accepted.**

NOTE: Please allow 24 to 48 hours after changing your name with Social Security Administration before applying to change it with the Florida Department of Highway Safety and Motor Vehicles. Your name must verify with the Social Security electronic system to obtain a Florida driver license or identification card.

Certified copies of marriage certificates or divorce decrees may be obtained at the clerk of court in the county where it was originally filed.

Immigrant

Immigrants renewing, replacing, or applying for a new driver license or ID card in person must submit the following documents before a REAL ID-compliant driver license or ID card can be issued. Please note that the name assigned to the Social Security Number (SSN) **must match** the name that will appear on the Florida driver license or ID card. If you have recently changed your name, you should update your records with the Social Security Administration before applying for a driver license or ID card.

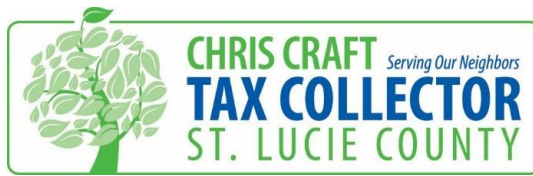

Primary Identification

1. An original of **one** of the following documents with complete name:
 - Valid alien registration receipt card (green card, form I-551);
 - I-551 stamp in passport or on I-94;
 - Immigration judge's order, containing your A-number (admissions number), granting asylum; Notice to Appear, containing your A-number (admissions number).
 - I-797, with your A-number, stating that you have been granted asylum; or
 - I-797, or another form from the United States Citizenship and Immigration Services (USCIS), with your A-number, stating your application for refugee status is approved.

Proof of Social Security

2. An original of **one** of the following documents with complete name and complete SSN:
 - [Social Security card](#) (with your current name);
 - Self-Certification Form (number must verify in our system)
 - W-2 form (not handwritten);
 - Paycheck/stub;
 - SSA-1099; or
 - Any 1099 (not handwritten).

Proofs of Residential Address - **Class E, Learner's License & Identification Cards ONLY**

Non-Immigrant

Non-immigrants renewing, replacing, or applying for a new driver license or ID card in person must submit the following documents before a REAL-ID compliant driver license or ID card can be issued. Please note that the name assigned to the Social Security Number (SSN) **must match** the name that will appear on the Florida driver license or ID card. If you have recently changed your name, you should update your records with the Social Security Administration before applying for a driver license or ID card.

Primary Identification

1. An original of **ONE** of the following documents with complete name:
 - Valid employment authorization card issued by the U.S. Department of Homeland Security (DHS) form I-688B or I-766;
 - Non-expired proof of non-immigrant classification provided by DHS form I-94 with required supporting attachment(s). If you are unsure of the required documentation, you should bring **all** United States Citizenship and Immigration Services (USCIS) documentation with you. I-94s must be accompanied by a valid passport with a date of entry stamp. Certain classifications require additional documentation. Some examples are:
 - F-1 and M-1 classification must be accompanied by an I-20;
 - J-1 or J-2 designation must be accompanied by a DS2019;
 - Refugee, asylee and parolee classifications must be accompanied by additional documentation;
 - I-571 travel document/refugee travel permit;
 - I-512 parole letter accepted; or
 - Immigration judge's order granting asylum or cancellation of removal.

NOTES:

- Documents must be valid for more than 60 days from the date of issuance.
- Non-U.S. citizens applying for an original driver license will be issued a 60-day temporary paper permit without a photo and a receipt. Non-U.S. citizens applying for an ID card will be issued a receipt. Upon identity and legal status verification, a driver license or ID card will be issued within 60 days and mailed to the address on the driver record. The driver license or ID card will be issued for the period of time specified on the USCIS document, up to a maximum of four years.
- If lawful status or identification is not verified, a denial of issuance letter will be mailed to you.

Proof of Social Security

If you are in the country without a work visa, you are **not** required to obtain a letter from the Social Security Administration stating that you were never issued an SSN (also known as an SSA refusal letter).

Canadian

Canadians renewing, replacing, or applying for a new driver license or ID card in person **must** submit the following documents before a REAL-ID compliant driver license or ID card can be issued. Please note that the name assigned to the Social Security Number (SSN) must match the name that will appear on the Florida driver license or ID card. If you have recently changed your name, you should update your records with the Social Security Administration before applying for a driver license or ID card.

Primary Identification

1. An original of **one** of the following documents with complete name:
 - Valid Canadian passport;
 - Original or certified Canadian birth certificate;
 - Canadian naturalization certificate; or
 - Canadian certificate of citizenship.

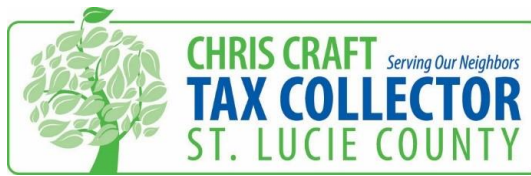

NOTE: If you have legally changed your name by marriage, divorce or court order, you must have your name changed on your Canadian driver license and/or passport before applying for a name change on your Florida driver license or ID card.



CDL and CLP Address Requirements:

The Certificate of Address form is NO LONGER acceptable for CLP and CDL issuances.

Commercial Driver License (CDL) and Commercial Learners Permit (CLP) applicants must present two proofs of Florida residential address in their name. You must submit one from list A and one from list B OR two proofs from list A. If you are unable to provide a proof of residential address from list A, you must provide a Declaration of Domicile filed with the Clerk of the Circuit Court pursuant to Florida Statutes section 222.17 AND one proof of residential address document from list B.
